## When will Vimly stop accepting contributions?

Vimly will stop accepting contributions on March 31, 2026. Beginning April 1, 2026, all contributions must be submitted through BPA's new online employer portal or via mail.

## Will the employer process for reporting contributions change?

## How do employers get access to the new BPA PORAC Employer Portal?
